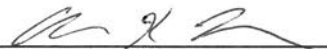

Donors may deduct contributions to you under section 170 of the Code.

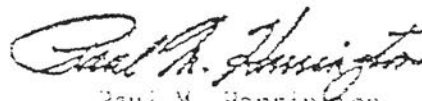
