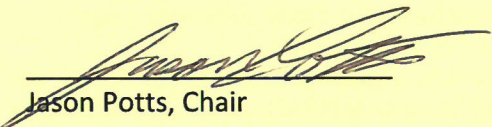
Making or allowing the sale of beer to a person under 21 years of age where the burden of ascertaining the age of customers was upon the owner or operator of such place of business.
