3. **Consideration Of Application Of Friends Of Franklin Parks, D/B/A Franklin Family Splash & Dash, The Park At Harlinsdale Farm, 239 Franklin Rd, Franklin, TN 37064, Taylor Suggs, Managing Agent, For Special Event, Event Date And Hours: June 15, 2024, 9:00AM - 2:00PM**

Taylor Suggs, Community Outreach and Engagement Coordinator for Friends of Franklin Parks, was in attendance to answer any questions from the Board. Ms. Suggs explained that this is the first annual Franklin Family Splash & Dash, and it is a fundraiser for the riverwalk and trails in our community. The event is essentially a "triathlon" event. It starts with a float down the river, followed by an optional 5K or fun run, and then a bike ride around Harlinsdale Farm. The event will end at Tractor Supply Co. Arena where there will be food vendors, activation stations from their sponsors, and beer served by Curio Brewing.

Alderman Barnhill asked how many people are currently signed up to participate?

Answer: 71 are signed up currently, but we expect walk-ups the day of. Our best guess is about 150 participants.

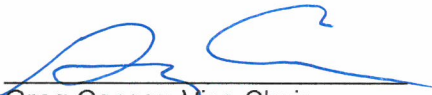
