ORDINANCE 2024-52

AN ORDINANCE TO AMEND THE CITY OF FRANKLIN MUNICIPAL CODE, SECTION 8-209, TO CLARIFY THE TYPES OF BEER PERMITS THAT MAY BE ISSUED BY THE BEER BOARD

WHEREAS, in order to promote the health, safety, human rights, prosperity, and general welfare of the people of Franklin, Tennessee, the Board of Mayor and Aldermen is authorized to prescribe regulations and standards related to beer within the City; and

WHEREAS, section 8-201 of the Franklin Municipal Code makes it lawful to transport, store, sell, distribute, possess, receive, or manufacture beer within the City of Franklin subject to the rules and regulations of the City; and

WHEREAS, section 8-203 of the Franklin Municipal Code establishes a beer board composed of at least three members of the governing body of the City of Franklin; and

WHEREAS, section 8-208 of the Franklin Municipal Code establishes the powers of the beer board which include issuing permits for manufacturing and distributing beer within the City of Franklin; and

WHEREAS, section 8-209 (1) lists three types of permits that may be issued by the beer board, including permits for off premises consumption, on premises consumption, and special event permits, but does not list manufacturer and distributor permits; and

WHEREAS, the Board of Mayor and Aldermen desires to clarify that the beer board is authorized to issue beer manufacturer and distributor permits; and

WHEREAS, the Board of Mayor and Aldermen find that this action to be in the best interest of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF FRANKLIN BOARD OF MAYOR AND ALDERMEN, AS FOLLOWS:

SECTION I. Sec. 8-209 (1) is deleted in its entirety and amended to read as follows:

- (1) *Permit required.* No person shall engage in the storing, selling, distribution, giving away, or manufacturing of beer, or other beverages of like alcoholic content, within the corporate limits of the City of Franklin until that person shall receive a permit to do so from the Beer Board of the City of Franklin or the city recorder. Four types of permits may be issued by the beer board:

a) A retailer's "off premises" permit shall be issued to any person engaged in the sale of beer for consumption and not for resale where the beer sold is not to be consumed by the purchaser upon or near the premises of the seller;

b) A retailer's "on premises" permit shall be issued to any person engaged in the sale of beer where the beer is to be consumed by the purchaser or his guest upon the premises of the seller;

- c) A manufacturer and/or distributor permit; and
- d) A special event permit.

A single permit for both on- and off-premises sales may be issued to an applicant. Permits shall at all times be subject to all of the limitations and restrictions provided under this code and state law and the applicant shall certify that he has read and is familiar with the provisions of this chapter.

SECTION II. BE IT FINALLY ORDAINED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that this Ordinance shall take effect from and after its passage on second and final reading, the health, safety, and welfare of the citizens of Franklin, Tennessee, requiring it.
