Answer: No. Mr. Valentine explained that alcohol is only sold from the bar.

Alderman Barnhill asked if there was a full-fledged restaurant and bar in the lobby with wait staff?
Answer: No. However, all front desk staff, the bartender/cook (as they are usually the same person), and the front office manager will have their TABC license.

A motion was made by Alderman Clyde Barnhill, seconded by Vice Chair Greg Caesar to Approve the Beer Permit. The motion passed 3-0.

5. **Consideration Of Application Of Columbia Avenue 1, LLC, D/B/A Sam Market, 1535 Columbia Avenue, Franklin, TN 37064, Basem Gamil Sodky Rezkalla, Managing Agent, For Off Premises Consumption**

Basem Gamil Sodky Rezkalla, owner of Sam's Market, was in attendance to answer any questions from the Board. Ms. Davey explained that this is an existing business in the City, formerly known as Tim's Market, but there is a new name and new ownership. She added that this application is contingent on receipt of the final Certificate of Occupancy. Mr. Rezkalla explained that the store will no longer have an operational deli. It will focus on convenience store items such as cigarettes, beer, and soft drinks. This is his second business in Middle Tennessee, and he also sells beer at his location in Nashville.

Alderman Caesar wanted to ensure that the sale of beer aligned with Franklin's ordinances because it could be done differently in Nashville.

A motion was made by Vice Chair Greg Caesar, seconded by Alderman Clyde Barnhill to Approve the Beer Permit Contingent Upon Receipt of the Certificate of Occupancy. The motion passed 3-0.

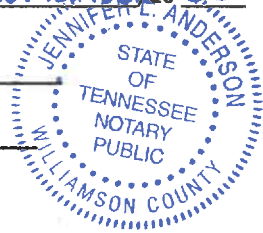




